CALL FOR PAPERS

As our relational theories move us beyond the "talking cure" toward the unspoken and the implicit, the clinical encounter can seem both infinite in possibility and, simultaneously, unmoored. It challenges us to wonder how we navigate the verbal and nonverbal, the perceptual and experiential and what is permissible and impermissible in our clinical work. Drawing on more established as well as emerging insights from the multiple analytic perspectives within our comparative "big tent," we will gather in Los Angeles to promote a clinically grounded, multi-generational conversation. By listening closely together to both the drama of specific clinical moments and the stories of patients and therapists deeply entwined in the ongoing therapeutic relationship, we hope to challenge and enlarge our vision of relational psychoanalysis today and for the future. We welcome all IARPP members to submit **PROPOSALS ONLY** for individual papers and/or panels pertaining broadly to the conference theme. To be considered, proposals for individual papers **MUST BE BETWEEN 500 AND 600 WORDS IN LENGTH**. Panels should include no more than three papers on a chosen topic. Proposals for panels should be no longer than 1200 words in total, and should consist of both an overview and abstracts of individual papers. Quality of writing, originality, integration of theory and awareness of current literature, clinical implications, and contribution to the field will all be considered.

The Conference Committee may group individual papers that are accepted for presentation with other papers in any session. Discussants for panel may be suggested, but cannot be guaranteed. Please note that while multiple proposals may be submitted, only one presentation per participant will be allowed due to the limited time slots. Proposed submissions cannot have been presented at a previous IARPP conference. **FINAL PAPERS** will only be requested upon the acceptance of your proposal for the conference. Final papers should not exceed 3000 words and will be due by and **no later than Monday, March 16, 2020**. All papers are to be submitted in English.

***** PROPOSAL SUBMISSION PROCESS *****

The **deadline for receipt of proposal submissions is MONDAY, SEPTEMBER 30th, 2019**. **No names should appear on your proposal submission** as reviews are anonymous. You must submit your proposal as an email attachment sent to nilou@km-direct.com. In addition to your proposal materials, please be sure to include 3 Educational Objectives, the title of your paper and, if proposing a panel, the title of your panel with a detailed, one paragraph Abstract.

Please submit the following materials:

1. Call for Papers **Cover Sheet** (electronic version available at www.iarpp.net)
2. One paragraph **Abstract** and **THREE Educational Objectives** for your presentation (These statements must clearly describe what the learner will know or be able to do as a result of having attended your presentation. Learning objectives must be observable and measurable (e.g., list, describe, apply, analyze, assess, utilize, critique, etc.) *These items should be on the same page and must be typed.*
3. Current **Curriculum Vitae** AND a one-paragraph Bio Sketch of current professional work.
4. Completed proposal as described above with author's name removed.

Due to continuing education application requirements, all of these materials must be submitted in order for your proposal submission to be reviewed. We regret that presentations submitted *without* all of the above items **cannot be considered**. All proposal submissions will be reviewed by the Program Committee. Authors will be notified of the Committee's decision by **mid- to late-November**. Acceptance is limited by space availability.
